#### General Comments/Feedback

Energy Storage Canada requests for the IESO to not restrict the eligibility of BTM storage in the IEE program. BTM storage is not promoted through other government programs, regulations or subsidies. While the ICI sends a price signal to shift consumption, it is not solely focused on promoting the use of BTM energy storage facilities to help C&I customers better manage their consumption.
